

Collect your fees on time, every time



What provisions are in place for Data Protection?

ConnectChildcare is ISO9001 certified and are registered with the ICO, Information Commissioners Office, which means that they must comply with strict Data Protection legislation. ConnectChildcare data is housed in highly secure data centres.

1 The ICO use three terms to define the different circumstances in which the Data Protection Act applies.

The Data Controller: You as a childcare provider act as a Data Controller. As Data Controllers, you own the data. The Data Controller determines the purpose and the manner in which any personal data is to be processed.

The Data Processor: ConnectChildcare is the Data Processor as our software processes the data on your behalf.

The Data Subjects: The children and parents are the Data Subjects.



2 Who can view data on ConnectChildcare?

ConnectChildcare requires users to access the software using a unique user log in. Initially the Nursery Manager or Owner will be set up with a log in and they can decide who else is given access.



3 Can ConnectChildcare staff members access my data?

Staff members at ConnectChildcare follow a strict code of conduct. We are governed by ICO and Data Protection guidelines. Our staff will only access data in order to help nurseries with support issues.




4 How safe is my data?

Your data is kept safe using industry standard security protocols and data storage facilities. These measure up to ISO27001, the international standard in information security management.



5 Where is the data stored?

Your data is hosted on secure UK based, highly resilient data centres with follow ITIL v3 practices. The secure data centres are certified to international ISO27001 standards, meaning they are test against strict security criteria.



6 What back up process is in place?

Full backups are taken every two to four weeks and a log backup is taken every 30 minutes, if the database has been updated since the last log backup. Once a backup has been taken of the database, the service will then send the backup file to the failover server using a secure method.
